Introduction

Campaign for Popular Education (CAMPE) is an advocacy and campaign network operating in Bangladesh since 1991. It started its journey in 1990. Over the last three decades, it has grown a credible national coalition of nearly a thousand NGOs, researchers, teacher groups, education rights campaigners, and individuals sharing similar vision & mission and working to promote SDG-4/Education 2030 in Bangladesh.

During its inception stage, CAMPE mainly focused on access to education & literacy issues but gradually moved to quality of education, retention, and completion of the primary & secondary education cycle for both boys and girls. After 2015, CAMPE sharpens its focus aligned with SDG4 along with other relevant goals. The critical issues under SDG 4 include primary and secondary education, early childhood development, and pre-primary education. It has emphasized on equal access to technical, vocational, and tertiary education and relevant skills for decent work. It has specific programs on gender equality and inclusion, literacy, and numeracy to address the equity issues, including non-formal education and adult literacy programs and education for sustainable development and global citizenship.

To attain these targets, CAMPE also focused on the learning environment, quality and adequate scholarships and qualified and motivated teachers.

Besides, CAMPEs program interventions are focused on the quality, adversity, and financing of education, school to work transition, promoting innovations and addressing inequality.

An educated, creative, democratic, secular, progressive, humanitarian, and equitable and poverty free Bangladesh through education, active citizenship, and life-long learning.

Mission

The Mission of CAMPE is to mobilize its constituency to achieve equitable and quality education and lifelong learning for all that promote people's empowerment, agency, rights and dignity. Highlights

Overview

During the reporting period (July 2020 to June 2021), CAMPE has implemented the following projects at national and sub-national levels of Bangladesh:

- “Advocacy for Social Accountability(ASA),” supported by GPE through OXFAM IBIS;
- “Capacity Building focused on SDG 4.7”, supported by ASPBAE;
- “Citizen Voice for Effective Policies to Reduce Child Mortality Causes to Drowning”, supported by Global Health Advocacy Incubator (GHAi);
- “Education Watch 2020-21”, supported by UNICEF, Bangladesh;
- “Excluded People’s Rights (EPR) in Bangladesh”, supported by ManusherJonno Foundation (MJF);
- Study on “Explore challenges associated with the Metadata for Global Citizenship Education and ways to address those challenges”, supported by BANBEIS;
- “Empowering Girls through Education (EGE)” supported by Save the Children International (SCI), Dhaka;
- “Securing Rights of Women Domestic Workers in Bangladesh (Securing Rights)” with support from Global Affairs Canada (GAC) through OXFAM in Bangladesh;
- “Youth-led Action Research”, sponsored by ASPBAE.

Highlights of the Interventions for the period of July 2020 to June 2021

Coping with Covid 19

During the reporting period CAMPE was also affected like many other NGOs because of Covid 19 pandemic. Therefore, it was not possible to secure long term funding for CAMPE. During the year, only existing activities were continued by maintaining appropriate health and safety measures.

Besides, considering government regulations on health safety, the implementation modalities of the program had to change and given importance to use of virtual platform for Advocacy, Networking and Campaign related activities on education and skills focusing on learning loss and human centred recovery. CAMPE also initiated a number of discussions for narrowing the digital divide. The *major interventions were as follows:*

Advocacy

- Shikkha Songlap (Education Dialogue) was Initiated to discuss education-related issues and draw the attention of the policy-makers;
- CAMPE contributed to the Education Sector Plan (ESP) using SDG 4 as a critical reference document, which coincided with the 8th Five Year Plan (2020 - 2025) of GoB;
- CAMPE identified key challenges and future actions for the right to education, including the commercialization trends, and also focused on key advocacy issues and their relevance to Bangladesh through a consultation on the “Abidjan Principles”;
- The local education administration in the Hill area committed to providing language development training to the teachers who are responsible for providing Multilingual Education to the children from ethnic communities;
- Lobbied with the government, made submissions to the Ministers and published “Open Appeals” for increased allocation for education in the national budget and appealed to the concerned authorities to revisit government directives on additional VAT for internet use;
- CAMPE developed a set of “Competency Standards” and CBT Curriculum on “Domestic Work” and submitted it to the National Skills Development Authority (NSDA), which was approved by the Executive Committee of NSDA and uploaded on the NSDA Website.
- A national level sharing meeting on Rights and Wellbeing of Domestic Workers in Bangladesh: Exploring the Opportunities and Challenges for Policy Implementation was organized jointly by CAMPE and Oxfam in Bangladesh;
- A Roundtable Discussion title ‘MLE at Pre-Primary Level: Lessons Learnt and Way Forward’ was jointly organised by CAMPE and the daily ‘Samokal’ with support from Netz Bangladesh
- 2 meetings of the MLE Forum were held during the reporting period, where progress of MLE was discussed and drawn the policymakers’ attention to provide online education support in MLE;
- A webinar titled ‘Alternative Educational Support during Covid-19’ was organised under the EGE project of CAMP, aimed to share the experiences on how girl students developed their learning skills through using Tabs.
- A webinar titled ‘Importance of ICT in developing potential of Girl Students’ was organised to expand this support to the disadvantaged children across the country;
- CAMPE submitted a “Memorandum with a demand to withdraw of Primary Education Completion Examination (PECE) and the decision for establishment of the Primary Education Board ” to the Hon’ble State Minister, MoPME. The “Memorandum” called for

continuous scientific assessment of students without relying on memorization, guide books, private coaching and resorting to malpractices in the exams. The popular media in Bangladesh published the demands of CAMPE;

- CAMPE submitted the Civil Society's comments/suggestions on the proposed National Curriculum Framework 2021 to the NCTB and organized a number of consultations with CSOs and other thematic groups. CAMPE also shared salient features of the findings with ELCG members;
- CAMPE worked with the concerned officials for better uses of ICT for Education and contributed to revisiting the process to revise ICT for Education Master plan and follow-up interventions;
- CAMPE formed and organised 2 meetings of the "Consultative Forum" under the "Securing Rights" project to influence concerned policy makers to include domestic workers in the existing Labor Law and to review Domestic Workers Protection and Welfare Policy 2015;
- The national dialogue/consultations on drowning prevention with the aim of raising awareness on the issue and getting commitment to accelerate the DPP approval by respective ministries and departments.

Campaign

- CAMPE observed the "Global Action Week for Education (GAWE)" from 26 to 30 April 2021 involving the different stakeholders. About 2,000 people directly and more than 100,000 people indirectly (through print and electronic media) participated in the national and 20 sub-national consultations;
- CAMPE celebrated the "World Teachers Day (WTD)" on 5th October 2020 with the theme "Teachers: Leading in Crisis, Reimagining the Future". The day provided the opportunity to celebrate the teaching profession worldwide, take stock of achievements, and draw attention to the voices of teachers, who were at the heart of efforts to attain the global education target of "leaving no one behind";
- "International Literacy Day (ILD)" was observed at the national and community levels with the theme "Literacy teaching and learning in the COVID-19 crisis and beyond" focusing on the role of educators and changing pedagogies;
- CAMPE observed the "World Drowning Prevention Day 2021" along with other development partners, media, and academia organized by the Non-Communicable Disease Control (NCDC) Programme of DGHS.
- As part of the observance of International Women's Day focusing on Domestic Workers, CAMPE organized a Mobile Boul Sangeet (Boul Song) event particularly focused on "Domestic Workers Protection and Welfare Policy 2015" with a view to make aware and motivates masses on the Issues.

Community Engagement

- CAMPE in collaboration with its partner organizations e.g. PASS & SERAA organized 69 Maa Shamabesh, 47 Awareness sessions, 11 Periodic Interactions Meeting with local education and health authorities, 29 Periodic Meeting with CWG, 11 workshops with duty bearers and 15 Action Plan Monitoring meetings where 5672 participants participated and contributed;
- 17 Community Score Card Display Board were set up in Schools and Community Clinics in five (5) Unions of Panchagarh and Netrokona districts.

Social Audit/Governance

- CAMPE and PASS representatives jointly conducted a social audit in Joloishalshiri Government Primary School with the support of the Community Watch Group (CWG). The audit was focused on effective use of the SLIP funds of GOB in primary schools. The participants of the Social Audit workshop made commitment to revisit their school-based plans including reopening guidelines with instructions on how to keep schools clean and disinfected, maintain social distance, sneezing etiquette, washing hands, and use protective equipment for overcoming the current pandemic situation;

Youth Engagement

- The “Youth-led Action Research” enhanced the confidence of the participants to engage in social work and prepare them for the world of work. The engagement of both boys and girls made them feel proud and confident after joining this program as young researchers from the community;
- CAMPE taken some capacity-building initiatives for youths on SDG 4.7 and engaged with the Bridge 47 initiatives. Besides, CAMPE is assisting BANBEIS to identify Metadata challenges for Global Citizenship Education, which would improve the state of youth in education, including GCED and ESD;
- CAMPE organized 130 Skype call sessions among the girl students of urban and rural primary schools with a view to create enthusiasm and aspirations through sharing the importance of continuing education at home during the COVID-19 pandemic.

Media Engagement

- A TV talk show was organized with Channel-i to increase awareness among the policymakers and the general public on the benefits of literacy to the people and the sustainability of literacy activities;
- Another TV Talk show titled “Bangladesh Labour Law 2006 and Rights of Domestic Workers as Labour: Our Role” was jointly organized by CAMPE and Bangladesh Institute of Labour Studies (BILS) on 18 June 2021 on “Ekattor Sangoj” of Ekattor TV, as part of the observance of International Domestic Workers Day 2021;
- A “Wake-up Call” was published in two national dailies to highlight the significance of International Literacy Day (ILD) and to disseminate the message on the importance and opportunities in promoting the use of ICT in literacy for people's wellbeing and their socio-economic development;
- A webinar titled “Development of Life Skills and Occupational Skills for Domestic Workers: Our Role and Expectations” was jointly organized by CAMPE and the daily Samokal on 12 December 2020, as part of the observance of 16 days of activism;
- CAMPE published an “Open Appeal” to the Honourable Prime Minister containing number of demands for protection and wellbeing of domestic workers published in the daily “Samokal” on 8th March 2021 as part of observance of International Women’s Day.
- News and views published by the media (print and electronic) on literacy were shared with key stakeholders to advocate for the importance of literacy, use of ICT in literacy, NFE towards SDG4 focusing on target 4.6 in Bangladesh;
- CAMPE also published an “Open Appeal” to the Honourable Prime Minister of Bangladesh urging to protect the gains in education and prevent the roll-back and demanded to rise to 20% of the National Budget for education and to ensure adequate investment to make online and ICT-based learning environment.

Research, Documentation & Publication

- The effects of the COVID-19 pandemic point to the need for an “Education Watch 2021 Study” to examine the education consequences and appropriate responses, both immediate and longer term. A multi-stakeholder sharing session on the Preliminary Findings of the “Education Watch 2021 Study” was held on 17 January 2021.
- CAMPE prepared a “Policy Brief” on education response to address the COVID-19 pandemic situation. The Brief suggested to ensure education financing in the national budget, international development assistance, and greater cooperation on debt management;
- Developed “Spotlight Report” and contributed to the regional process of advocacy around the UN General Assembly in September 2020 on the VNR Process and also participated in the VNR reporting process of the government and raised the issue of most marginalized population;
- CAMPE has taken an initiative to document the Teacher Associations’ Profile to know the stories of how the teacher associations have grown in Bangladesh and how a member of visionary leaders contributed at different levels.

Capacity Building

- A day-long sharing workshop was organized for ensuring services to the domestic workers with a view to inform, motivate & sensitize the officials of the government service provider agencies to ensure necessary services to the domestic workers;
- The representative of CAMPE participated in the Project Design and Management trainings organized by the “Education out Loud” (EoL) regional office. The courses helped to improve confidence, capability, and understanding of project cycle management and the linkage between Planning, Monitoring, and Evaluation;
- CAMPE has been promoting ICT for education and engaged in developing the ICT for Education Master Plan, E9 Digital Learning Roadmap, and the use of ICT for education. Through its platforms, CAMPE has promoted the grassroots level teachers and learners to share their experience of using ICT that could contribute to building confidence among teachers and learners;
- CAMPE and development partners have organized 29 Citizen Support Group (Community Watch Group) orientations on primary education and health service governance to inform the role of CWG members and ensure good governance among service providers.
- CAMPE contributed for drawing attention of the educators and policymakers to address the grassroots challenges including access to ICT devices, connectivity, content, teaching-learning processes, capacity development needs assessment of learning, etc.
- Two orientation sessions on EGE project and its linkages with the government initiatives were organized.

National

- CAMPE participated in different government committees and task force meetings/trainings/capacity-building workshops to establish learning collaborative for strengthening civil society organizations. It has contributed to regular virtual meetings and involved in the Education Sector Plan, LEG & Education Cluster, National Actions for Drowning Prevention, and other State-led and CSO initiated processes;
- As an active member, CAMPE participated different programs organized by the "Shamajik Protirodh Committee" for advancing gender equality and gender justice at all levels. "Shamajik Protirodh Committee" is a platform of sixty-four (64) NGOs coordinated by Bangladesh Mohila Parishad (BMP) working to stop violence against women and promoting women's rights;
- As a core member of the Citizens' Initiatives on CEDAW, Bangladesh (CIC-BD), CAMPE participated planning meetings for proper implementation of CEDAW in Bangladesh;
- CAMPE participated and contributed to popularize the concept of Global Citizenship Education Development (GCED) initiated by UNESCO Dhaka;
- CAMPE attended meetings of the Civil Society Alliance (CSO Alliance);
- CAMPE participated in regular meetings of the "Back to School Campaign" alliance facilitated by SAVE.

Governance and Institutional Development

Statutory Meetings

- CAMPE Council (Board) met three (3) times and provided necessary strategic directions and guidance to the management during the reporting period;
- 23rd Annual General Meeting (AGM) was organized on 27 October 2020 using a virtual platform. A total of 125 members, NGOs from across the country have participated in the meeting;
- The Financial Oversight Sub-Committee (FOC), appointed by the Council, met several times for guiding the Management to manage the critical issues like preparation of 'Contingency Plan' and 'Interim Budget,' tax-related issues, etc.

ICT Services and Support

- The ICT management team provided required support for smooth functioning of the system that included server management on virtual platform, manage replica of all virtual

servers, ICT system security, data security, network security and management, troubleshooting, capacity building & knowledge transfer along with keeping computers free from virus and provided support to maintain the automated accounting system (Sage ERP);

- CAMPE's activities are now available on social media, Facebook, Twitter, YouTube etc. More than three thousand people followed the Facebook page during the reporting period;
- CAMPE live telecasted important public events through Facebook live stream which was linked to CAMPE website.

Management and Strengthening of Systems

Finance and Accounts

The finance unit has regularly prepared reports and statements for CAMPE and Development partners according to the budget line item and their costs disclosed control over the use of assets and helped the user to evaluate the organization's ability to accomplish its objectives. Reports were prepared on the basis of the six (6) principles.

Human Resource Development

Representatives of CAMPE attended various orientations, workshops, training, etc. conducted by development partners and other forums as a part of their continuous learning process.

Vacancy and Recruitment

Six (6) new staff joined and eleven (11) left due to the closure of some projects during the reporting period.

Administrative and Logistic Support

The Human Resource and Administration unit of CAMPE played its responsibility for general day-to-day administration, personnel management and provided all kinds of logistic support for smooth functioning of program activities.

Procurement

During this period CAMPE procured a number of products and services like IT equipment including laptops, computers, printers, etc. event management like publish 'Open Appeal' on the print media, publications of number books & other print materials and provided logistics support as required by the different projects within the approved budget line.

Asset and Inventory Management System

The Administration section is the custodian of fixed assets of CAMPE and maintains a list as per category and location. These include durable and reusable items such as vehicles, furniture & fixtures, office equipment, computers, etc.

Office Management & Maintenance

During the reporting period, the administration unit has maintained & supported programs and training facilities. It has also been monitoring utility and transport management, dispatch, repair & maintenance of equipment and office.

Key Achievements

- Considering the Proposal of Bangladesh UN assembly declarers World Downing Prevention Day in 24 July.
- Recommendations of Education Watch 2021 to Re-open school was supported by all stakeholders and finally it was considered by the Government and all education institution were re-opened with maintaining required health safety.

- Most of the recommendation submitted by CAMPE considered by the NCTB and incorporated in the new national curriculum framework (2021).
- Skills Standards and “Training Curriculum” on Domestic Works developed and submitted by CAMPE which was approved by National Skills Development Authority (NSDA) of Prime Minister Office.
- As per memorandum submitted by CAMPE, Ministry of Primary and Mass Education (MoPME) post ponded Primary Education Completion Examination and other equivalent Examination for the year 2021.
- Considering the recommendation of CAMPE; Government withdrawn decision to collect additional VAT for internet use.

Lessons Learnt and Forward Looking Areas:

- The COVID-19 pandemic has increased the demand for ICT in education and the need to integrate ICT effectively into teaching and learning. With this increased demand for use of technology and the gaps in digital skills identified, it is imperative to train students, teachers and parent’s guardians to use and integration of ICT;
- Virtual meetings have been introduced by CAMPE and its partners at a wide scale during the pandemic. But time management has always been a crucial thing in the online meeting platforms. It is often difficult for the moderator to manage time and get feedback from every individual as well as to let them be engaged in material sharing;
- The importance of online and distance education to address learning continuity and trauma related setbacks during COVID-19 became the main discussion points at CAMPE’s *Shikkha Songlap* and opened up opportunities to identify relevant actions;
- It has become critical issue to ensure that any consultation process is bottom-up and that local needs, priorities and expectations are reflected in national level policy discourse as identified through sub-national level consultations;
- “Abidjan Principle” has been found to be a worthy resource to the advocacy for increased State Financing for SDG-4 implementation and in the lobby for appropriate regulatory frameworks for the private sector in education;
- The “Spotlight Report” of CAMPE on SDG-4 implementation status in Bangladesh was found to be an opportunity to engage CSOs and policy-makers on highlighting the main achievements and key challenges;
- The inter-country exchanges participated by CAMPE have enhanced understanding and knowledge to perform better and to engage more efficiently with the policymakers on the COVID-19 response and education sector policy dialogues, among others;
- The prolonged lockdown has been the most crucial challenge to implement programs aggravated by the shrinking space for civil society. In addition, there are some field-level realities affecting the learning of children particularly from underprivileged communities and depressed areas.
- The continuing challenges of decreasing ODA combined with low national level investment in education have made it difficult for NGOs and other civil society actors to address COVID induced hardships among their program participants;
- Gender based deprivation has become acute the form of increased drop-out, early marriage and home based violence during the pandemic.
- However, COVID has also opened up many opportunities like ICT based education and Skills Training particularly for the Youth which could be utilized by CAMPE and its member organizations.

Programs

Advocacy

Shikkha Songlap

As a continuation of advocacy initiatives, particularly in COVID-19 pandemic period, CAMPE initiated to promote “Right to Education” and “Stakeholders Participation” in policy and practice change discourses. As part of this, CAMPE organized a number of *Shikkha Songlap* on Education. These are as follows:

1st Episode: Prospects and Challenges of Distance Learning during COVID-19

CAMPE organized the 1st Episode of “Shikkha Songlap” on ‘Prospects and Challenges of Distance Learning during COVID-19’ on 27 October 2020 emphasizing on protecting the right to education, addressing trauma, and continuity of education through distance learning.

A total of 70 representatives from CAMPE’s member organizations, INGO Forum, selected teacher associations, media, and the Education Watch Group members actively participated and provided their valuable suggestions/recommendations at the consultation.



2nd Episode: Education in Indigenous and Minority Languages

CAMPE organized the second episode of Shikkha Songlap on ‘Education in Indigenous and Minority Languages: Possibilities and Challenges’ with the participation of 5 linguistic minorities aimed to know the effectiveness of Multilingual Education (MLE), especially in terms of children’s learning outcomes to identify areas that need to be strengthened in the MLE curriculum and teaching-learning activities along with successes and challenges of MLE students.

A total of 62 participants included concerned government officials, representatives from Local Government, ethnic linguistic groups, teachers’, national enthusiastic person/researchers, School Management Committee (SMC) members, print and electronic media, professionals and child rights activists, and civil society actively participated and contributed in the virtual consultation.




3rd Episode: Education for Persons with Disabilities

CAMPE organized a *Shikkha Songlap* on 'Education for Persons with Disabilities: Challenges and Way Forward' on 15 December 2020 to share grassroots experience on the impact of Covid-19 on the education and livelihood of children with disabilities and to seek recommendations from experts and civil society actors in education for strengthening policy advocacy particularly on SDG-4. A total of 52 participants included representatives from the expert groups and civil society actors in education, persons with disabilities, teachers, SMC members, and guardians of protibondhi schools. Representatives from disability-focused organizations, teacher associations, sub-national level partners, and members of Education Watch, CAMPE Council, INGO Forums and journalists actively participated and provided their comments and suggestions at the consultation.



Consultation on Education Sector Plan

An alien with the Education 2030, SDG4 Strategic Framework for Bangladesh Vision-2041, and the Eighth-Fifth Year Plan, several initiatives have been taken to understand some ground realities and to finalize the Education Sector Plan by incorporating grassroots views, CAMPE organized 4 Virtual Consultations at the divisional/district level in cooperation with UNESCO and Education Out-Loud (Advocacy and Social Accountability). The objective of the consultation was to hear the stakeholder's perspective in developing the Education Sector Plan of Bangladesh towards achieving the National Vision and international commitments like Vision 2041 and SDG4, and others.



A total of 551 including 187 female participants from divisional/district level consultants including concerned government officials, local government representatives, local education administration, teachers (from different universities, College, School, and Madrasha), management committee members, guardians, representatives from CSOs, Journalists, representatives from youth groups and expert team member of ESP actively participated the consultation.

Abidjan Principle on the human rights obligations of States

A virtual Consultation on the 'Guiding Principles on Human Rights Obligations of States' was held on 27 March 2021, comprising Economists, Academicians, journalists, representatives of CSOs, and Youth Leaders. The objectives of the consultation were to understand the Abidjan Principles and identify the obstacles and challenges for rights to education and the commercialization trends. The consultation has to identify the key advocacy issues and their relevance to Bangladesh and provide recommendations for public education and private involvement in education. Disparity further increased for the COVID-19 outbreak, the

government must increase its investment for bringing equality in the education sector for ensuring quality education, said the discussants.

The consultation was chaired by Dr. Manzoor Ahmed, Professor Emeritus, BRAC University, and Vice-Chairperson of CAMPE. A total of 58 representatives from CAMPE's member organizations, Education Watch, academia and think-tank's, teacher associations, youth representatives and some selected journalists of the education desk, among others, attended the consultation.

CWG action plan and Citizen Charter

CAMPE in collaboration with PASS and SERAA have prepared thirty-six (36) festoons, five (5) CWG action plans and displayed citizen charter in five (5) unions and six (6) community clinics. By this process, the marginalized people could be able to realized and acknowledged services as well as find the way of receiving those services. They could contact the emergency hotline numbers for their needed solutions.



National Dialogue on Drowning Prevention

A virtual 'National Dialogue on Drowning Prevention' was jointly organized by CAMPE, BEN, CIPRB and SoMaSHTe on the 22nd of June 2021, in cooperation with GHAI. Hon'ble State Minister of MoWCA graced the event as Chief Guest. She thanked to the CAMPE including GHAI for raising the issue and made a commitment to amend/change the laws and policy related to ECCD and develop a national plan of action for drowning prevention. She added that the government has already identified child drowning deaths as a serious concern and as given due prioritizes for prevention. Meanwhile MoWCA has prepared and submitted a Detailed Project Pro-forma (DPP) for saving children's from drowning. It is expected to be implemented shortly.

Altogether 223 participants from diverse stakeholder groups attended the dialogue. Print, electronic and social media has covered the issue with special attention. In addition, a total of 28 special stories published by the media to emphasize the government and CSOs coalition preventing drowning.

Sub-National Consultation/Dialogue on Drowning Prevention

CAMPE organized six (6) sub-national consultations on reducing child mortality by preventing drowning death in collaboration with its partner organizations. The sub-national level consultations/dialogues were held at Barishal, Khulna, Rajshahi, Mymensingh, Sylhet and Rangpur divisions. About 55-75 people have participated in each consultation. The Mayor of the respective city corporation/pouroshova, Divisional Commissioner and Deputy Commissioner attended as the Chief Guest of the programs. Relevant government officials, people representatives, partner NGOs, CSOs, academia, teachers, practitioners, women and children rights activists and journalists attended the consultation and shared their views regarding drowning prevention in local level.



The sub-national consultations have received several recommendations for reducing the drowning and mitigate the challenges and constraint - effective policy adaptation, increase awareness, expansion of ECCD, establish daycare centers, safe swim facilities and life skill training.

Strategy Meetings with Champions

CAMPE has organized a Shiksha Songlap (3rd Episode) on the proposed National Curriculum Framework on 14 November 2020. The main objective of the virtual consultation was to provide new policy directives in education focused on rights and exclusion perspectives. The meetings contributed to the draft National Curriculum Framework, initiated by The National Curriculum and Textbook Board (NCTB).

A number of the champions from CSOs and other thematic groups, Education Watch Group, CAMPE Council members, academics, teachers, and experts are well conversant with pedagogy and curriculum-related issues.

Consultations on Education Financing

CAMPE organized two sub-national level consultations to raise awareness and to communicate the grassroots realities with the policymakers on education financing. More than 120 participants comprising of students, teachers, government duty bearers, journalists, SMC members, and CSOs participated the consultations. The consultation created a platform to raise citizen's voices around the issues related to allocation for education in the National budget. It is impossible to ensure quality education without allocating sufficient budget for higher education to create skilled workforces, says Deputy Commissioner (DC) Abdul Matin while speaking as the chief guest in the Consultation on Education Financing at Gaibandha on 17 February 2021.




The participants of the consultations raised demand to allocate more budget for education sectors in the National Budget, including improving the quality of infrastructure of primary and secondary schools and TVET centers. The participants also raised the demand to enhance teacher's capacity and use of ICT in education; address poverty-driven dropouts; strengthen the second chance education, and to create lifelong learning opportunities.

Approval of Competency Standard and CBT Curriculum on Domestic Works

Under the SUNITI project, CAMPE has developed a set of Competency Standard and CBT curriculum on Domestic Works, which was submitted to the National Skills Development Authority (NSDA) for final approval. After a persistent advocacy with the National Skills Development Authority (NSDA) and Informal Sector Skills Industry Council (ISISC), finally the National Skills Development Authority (NSDA) approved the Competency Standard and CBT curriculum on Domestic Works and uploaded NSDA website.

Formulation of Consultative Forum

To take advocacy initiative to formalize the occupation of domestic work as well as ensure rights and wellbeing of domestic workers, CAMPE has formed a Consultative Forum with the Member of Parliament, government officials and CSOs representatives. During the reporting period, two meetings of the Consultative Forum were held on 30 December 2020 and 28 March 2021 respectively. Mr. Fazle Hossain Budsha, MP was present as the Guest of Honor in both meetings. Mirza Nurul Ghani Shovon, Chairman, Informal Sector Industry Skills Council (ISISC) chaired both the meetings.



Mr. Fazle Hossain Badsha, MP said that the occupation of domestic workers should be recognized as a formal occupation. To earn formal recognition, it is necessary to establish an employer and employee registration system to ensure accountability of employers and employees. He added that we can lobby with the Parliamentary Standing Committee.

Number of important decisions/suggestions/recommendations were made in the meetings.

Sharing Meeting on Rights and Wellbeing of Domestic Workers in Bangladesh: Exploring the Opportunities and Challenges for Policy Implementation

To inform the policymakers about the situation of domestic workers as well as the implementation of Domestic Workers Protection and Welfare Policy 2015, CAMPE and Oxfam in Bangladesh jointly organized a 'Sharing Meeting titled 'Rights and Wellbeing of Domestic Workers in Bangladesh: Exploring the Opportunities and Challenges for Policy Implementation' on 3 March 2021 at CIRDAP Auditorium.

A total of 86 participants including 38 female from concerned governed agencies like Ministry of Labour and Employment(MoLE), Department of Labour(DoL) Bureau of Manpower Expert and Training(BMET), National Skills Development Authority (NSDA), people representatives, representatives from partners NGOs, domestic workers, employers, journalists were present in the sharing meeting. Mr. K. M. Abdus Salam, Secretary, MoLE was present as Chief Guest. Mr. Dipankor Dutta, Country Director Oxfam in Bangladesh chaired the meeting.




Ms. Rasheda K. Choudhury welcomed the participants of the meeting. ED had mentioned that a large number of people are employed as domestic workers. She emphasized on assessment of the implementation status of the policy and explored the possibility to formulate a legal framework. A brief presentation on the SUNITY project was made followed by an open discussion.

Mr. K. M. Abdus Salam, Secretary, MoLE said in his speeches that the government has been working with the Domestic Workers Protection and Welfare Policy 2015. In this regard, the government has established a monitoring cell on Domestic Work and strongly considering the issue of child labor. He admitted that there is a lack of implementation of the policy and committed that the MoLE will take all possible initiatives to bring it on the government priority list.

1st Episode: Webinar on ‘Importance of ICT in developing potential of Girl students’

A webinar on ‘Importance of ICT in developing potential of Girl students’ was organized on 25 May 2021 with the participation of Policymakers, Development Partners and other Stakeholders.



The meeting was chaired by Dr. Manzoor Ahmed, Vice Chair, CAMPE and moderated by Rasheda K. Choudhury, Executive Director, CAMPE and Advisor to the Former Caretaker Government.


Professor Dr. A.K.M. Reazul Hasan, Member (Primary Curriculum), National Curriculum and Textbook Board (NCTB) and Dr. Quazi Faruque Ahmed, Member, Education Policy 2010 Formulation Committee graced the occasion as Guest of Honor. Md Jobayedur Rahman, Director (Training), Directorate of Primary Education (DPE), Mohiuddin Ahmed Talukdar, Deputy Director (Pre-Primary), Directorate of Primary Education, Md. Afzal Hossain Sarwar, Policy Specialist (Education Innovation) a2i, Ms. Nur-a- Tasnim, Upazila Nirbahee Officer, Rajarhat Upazilla, Kurigram Dr. Narayan Kafle, Director, Education

Department, Save the Children, Brig Gen Ilyas Iftekhar Rasul, Director & Head of Education, Friendship, A. H. M. Raihan Kabir, Upazila Education Officer, Rajarhat, Kurigram, Md. Khurshed Alam, Upazila Education Officer, Madargonj, Jamalpur were present as guest speakers.

A total of 62 participants including concerned government officials, educationists, and representatives from teachers' associations, representatives of boys and girls students, parents and teachers from EGE project areas attended the webinar.

2nd Episode: Webinar on 'Importance of ICT in developing potential of Girl students' with NGOs and INGOs

CAMPE's EGE team also organized a webinar with NGOs and INGOs titled 'Importance of ICT in developing potential of Girl Students' on 15 June 2021 with the participation of the representatives of NGOs and INGOs. The webinar was chaired by Rasheda K. Choudhury, Executive Director, CAMPE. A total of 148 representatives from different national and sub-national level NGOs and INGOs attended the webinar. Prof. Tariq Ahsan, Ph.D.- IER, Dhaka University and Dr. Safiqul Islam, Director, BRAC-Education Program graced the occasion as Guest Speakers. The webinar was moderated by Dr. M. Ehsanur Rahman, Executive Director, Dhaka Ahsania Mission.



Mr. Shahin Islam, Project Director, highlighted the ongoing activities implemented by CAMPE and FRIENDSHIP during the COVID-19 pandemic with support from Save the Children and also mentioned that alternative learning spaces are being created where the EGE project has been continuing alternative education support to the students, parents and other stakeholders.

MLE Initiatives of CAMPE

Meeting MLE Forum

CAMPE organized a virtual meeting of MLE Forum on 22nd September 2020. The meeting was chaired by Prof. Dr. Shorov Sikder. A total of 13 members were present in the meeting. Prof. A. K. M. Reazul Hasan, Member (Primary Curriculum), National Curriculum and Textbook Board(NCTB) was present as 'Guest of Honor'. The meeting discussed the issues like 'how the MLE program is running at the field level during COVID 19 pandemic situation and coordination mechanism between national and local initiatives etc. After a threadbare discussion, number of decisions were made in the meeting of MLE Forum.

Roundtable Discussion on 'MLE at Pre-Primary Lesson Learnt Way Forward'

In order to disseminate the finding of an action research on pre-primary education for adibashi children during COVID 19 pandemic situation jointly implemented by Ashroy-Rajshahi and Netz Bangladesh, CAMPE organized a Roundtable Discussion title 'MLE at Pre-Primary Level: Lesson Learnt and Way Forward' on 28th December 2020 jointly with the daily Samokal.

Mr. Fazle Hossain Badsha, MP and Member of Parliamentary Standing Committee on Ministry of Education (MoE) was present *as 'Chief Guest'*. Ms. Rasheda K. Choudhury, Executive Director of CAMPE and Former Adviser to the Caretaker Government was in the Chair in the Roundtable Discussion.

Campaign

Observance of Global Action Week for Education (GAWE)

CAMPE organized and facilitated a national consultation and twenty (20) sub-national consultations in collaboration with its member/partners organizations as part of observance of Global Action Week for Education (GAWE) from 26 -30 April 2021 in Bangladesh. About 2,000 different level of stakeholders directly participated these virtual consultations. Moreover, 100,000 active citizens have been reached indirectly through print and electronic media.

Mr. M. A. Mannan MP, Hon'ble Planning Minister grace the occasion as the Chief Guest. Ms. Aroma Datta, MP and Member of the Committee on Government Assurances, Bangladesh National Parliament joined the event as Chief Guest. Md. Mahbub Hossain Secretary, Secondary and Higher Education Division of the Ministry of Education, was present as Special Guest of the session. Dr. Q. K. Ahmad, Chairman, PKSF and Chairperson, Education Watch, preside over the consultation. Besides many eminent personalities, including Dr. Manzoor Ahmed (Vice-Chair of CAMPE), Ms. Farah Kabir (Country Director, Action Aid Bangladesh), Dr. Ehsanur Rahman (Executive Director, DAM), Principal Quazi Faruque (Chairperson, IHD, and teachers' leader) joined the session as distinguished Guest Speakers.

The program was supported by the Education Out Loud-Advocacy for Social Accountability of the Global Partnership for Education (GPE).



Celebration of World Teachers Day 2020

CAMPE celebrated World Teachers Day (WTD) on 5th October 2020, with the theme 'Teachers: Leading in crisis, reimagining the future'. The day has provided the opportunity to celebrate the teaching profession worldwide, take stock of achievements, and draw attention to the voices of teachers. Teachers are at the heart of efforts to attain the global education target of leaving no one behind. CAMPE, continuing its efforts to promote, reiterated the issues relating to valuing and empowering Teachers through several activities to celebrate the WTD. The events were organized at national and sub-national levels in cooperation with teacher associations, member/partner organizations, and other relevant stakeholders. The major programs of WTD included virtual consultations, media mobilization, publication of the open appeal, and printed posters. A total of 320 people have participated in WTD consultations, and 10,000 posters were printed and distributed among stakeholders through member organizations and teachers associations.


Teachers are the foundation of quality, inclusive, public education systems, says Mr. Mustafa Jabbar, Honorable Minister, Ministry of Posts, Telecommunications, and Information Technology, while speaking as the Chief Guest at a Virtual Consultation on World Teachers Day 2020. He emphasized that the

education system needs to be digitally transformed shortly, and it has to be started from primary education. He expressed hope that by 2021, Bangladesh will be covered by high-speed internet connection and turns each secondary school in the country into a "digital academy" to prepare the youth with skills and knowledge for the fourth industrial revolution.

International Literacy Day (ILD) 2020

CAMPE has observed the International Literacy Day (ILD) 2020 and the International Literacy Day 2020 with the theme 'Literacy teaching and learning in the COVID-19 crisis and beyond focusing on the role of educators and changing pedagogies'. The main objective of the event is to spread education to all sections of society. The theme highlighted the literacy learning in a lifelong learning perspective and therefore mainly focuses on youth and adults. The Covid-19 crisis has been a stark reminder of the existing gap between policy discourse and reality - that already existed in the pre-Covid-19 era and is negatively affecting the learning of children and youth.

In this regard, CAMPE has organized a TV talk show with Channel-i to increase awareness among the policymakers, general public on the benefits literacy brings to the people and the



sustainability of literacy activities. A wake-up call was published on September 8, 2020, in two national dailies both in Bangla and English to highlight the significance of ILD and to disseminate the message on the importance and opportunities in promoting the use of ICT in literacy for people's wellbeing and their socio-economic development.

Observance of International Women's Day

As part of the observance of International Women's Day focusing on Domestic Workers, Campaign for Popular Education (CAMPE) organized a Mobile Boul Sangeet (Boul Song) particularly focused on Domestic Workers Protection and Welfare Policy 2015 with a view to aware and motivates masses on the Issue.



CAMPE and its partner organizations (PASS & SERAA) conducted forty-seven (47) awareness sessions, where a total of 1,459 (male - 311 and female - 1,148) excluded/marginalized people participated from five (5) Unions of Panchagarh and Netrokona districts. The performance of the learners, education continuation, children drop out from schools, health and hygiene practice considering COVID-19, child nutrition and food, and other social issues like early marriage, dowry, gender and VAW, etc. was the major discussion points of the meetings.



Community Engagement

Parents gathering to increase involvement of child learning process

CAMPE organized mother/parent gatherings in each school and community clinic in the project area. The objectives of the mother's gathering were to continue education of the children and to create home-based online learning environment for the children. A total of 69 mothers/parents gathering were organized, where male-539 and female-2,011 participated including SMC members, Community Watch Group (CWG) and Upazila level education officials.



Civic engagement and empowerment for CWG's institutionalization

CAMPE and its partner organizations facilitated 29 periodic meetings of the Community Watch Group (CWG), where a total of 581 (male-406 and female--175) participants attended from 05 Unions in Panchagarh and Netrokona districts. Major discussion points of the meeting were the importance of the project, goals, and activities. The CWGs' roles and responsibilities have been discussed in detail to ensure better education and health services for the excluded groups. By this meeting, the CWGs played as a pressure group as well as a linking channel of service providers between rights holders.



Periodic Interaction meeting among Service providers and Rights holders

CAMPE and its sub partner PASS and SERAA organized 11 Periodic Interaction Meetings where 125 male and 54 female participants attended from government and non-government service provider agencies/organizations. The objective of the event were to share the actual scenario of service delivery among the service providers and rights holders and find out the challenges and to identify the challenges and way forward. The responsible stakeholders shared about their citizen supports, discussed how the community can be engaged for monitoring the service delivery mechanism.



Engagement of Community Radio for Drowning Prevention

CAMPE and selected Community Radio's organized and broadcast talk shows, open discussion, awareness programs, jingles drama and magazine programs on drowning prevention to increase the awareness level of the community, stakeholders and draw the attention of policymakers. The selected Community Radios e.g. Radio Padma in Rajshahi, Radio Banalata in Sathkhira, Radio Chilmarī in Kurigram and Radio Pallikantha in Moulvibazar) organized discussion programs with the participation of local administration,

law enforcement agencies, guardians, teachers, students, members of SMC, journalists, development activists and CSOs. The Community radios also aired special interviews regarding drowning prevention with specialists/experts and local administrations.

The Community radios have covered eleven (11) districts of four (4) divisions and outreach approximately 2 million

Awareness Sessions for Girl's Education

CAMPE organized 7 teachers and parents meetings, where 62 teachers, parents, SMC members and students attended. The objectives of events were to continue girls' education, increase participation of the girls students in skype call sessions and to create awareness on the importance of ICT in education, negative impacts of early marriage and prevent early marriage, safeguarding issues and to share EGE project.



The meetings has enhanced the awareness of teachers and parents on the issues. As a result teachers and parents gradually contributed to enhance the participation of girls in Skype calls, child marriage reduction, and ICT-based education.

Social Audit initiative

CAMPE, as the national education coalition, has taken an initiative to promote accountability in primary education through Social Audit. The Social Audit initiative promotes citizens' voices to enhance efficiency in using the School Level Improvement Plan (SLIP) money through monitoring activities. In the long run, it will help to establish school-level accountability, improve good governance and reduce financial risks.



A total of 103 representatives of the SLIP oversight committee from twenty (20) schools has participated. Some selected schools revisited their school-based plans including reopening guidelines with instructions on how to keep schools clean and disinfected, maintain social distance, sneezing etiquette, how to wash hands, and use protective equipment for overcoming the current situation. They also committed to organizing a back-to-school campaign at the community level with support from school managing committees, local government bodies and NGOs.

Youth Engagement

To create enthusiasm and aspirations among the girl students of rural primary schools, an interactive skype call sessions was designed among the girls student of good performing urban primary schools and rural primary schools under EGE project. During the reporting period, a total of 130 skype call sessions have been conducted, where a total of 822 girl students from selected urban schools participated in the sessions.

During the skype call session, the girls shared the importance and ways and means to continue education at home during the COVID-19 pandemic situation. Also shared their dreams, ambitions, experience, education-related issues, exchanged ideas among each other.



Youth-led Action Research

CAMPE conducted a youth-led action research through empowering of youth during the pandemic. Youth-led action research enhanced the participants' confidence to engage in social work, address local issues in education, and prepare them for the world of work. This action research has provided some food for thought to understand the impact of the covid-19 pandemic on how youth are facing adversity. It has tried to give some selected youth cases about how they have grown up



and how the pandemic has impacted their lives, livelihood, education, and access to healthcare facilities. It has emphasized the importance of formal and non-formal education and technical and vocational education and training as part of lifelong learning. Both boys and girls feel proud and confident after joining this program as a young researcher from the community. They also engage with the local government institutions and other duty bearers to proclaim their right to education and better living. They have used an online survey to collect household-level data.

Media Engagement

Press Briefing on the “Interim Report” on the Education Watch Study 2020

CAMPE organized a virtual Press Briefing on the Interim Report of the Education Watch Study 2020 titled 'Covid-19 Pandemic School Education: Status, Response, Challenges and Prospects' on 19 January 2021. A total of thirty-seven (37) participants including journalists from print, electronic and online media, researchers and resource persons have participated in the program. A brief presentation based on the study findings was presented before the media personnel. Later on a question-answer session was held.



Webinar on Development of Life Skills and Occupational Skills for Domestic Workers: Our Expectation and Role'

As part of the observance of 16 days of activism, CAMPE and the daily Samokal jointly organized a webinar titled 'Development of Life Skills and Occupational Skills for Domestic Workers: Our Expectation and Role' on 12 December 2020. Ms. Shirin Akhter, MP and Aroma Dutta, MP were present in the webinar as a Guest of Honour. Rasheda K. Choudhury, Executive Director of CAMPE, presided over the webinar. During the webinar, a set of recommendations have been made on the issue.



The following day, a detailed report on the webinar was published in the daily Samokal on 13 December 2020. The news had reached at least about three million people through print and online and social media (Google, Facebook, Twitter account)

An "Open Appeal" to the Hon'ble Prime Minister


As part of the observance of International Women's Day (IWD), CAMPE also published an 'Open Appeal' to the Hon'ble Prime Minister of the Government of Bangladesh in favor of domestic workers. The open appeal raised the issues such as to formulate legal framework and necessary ordinance to implement Domestic Workers Protection and Welfare Policy 2015; recognize domestic workers as formal labour and bring them under Bangladesh Labour Law; ensure implementation of directives of high court regarding the appointment of below 12 years aged children as domestic workers; take the initiative to ratify ILO convention 189 related to decent work and some other important issues.



Another Open Appeal to the Hon'ble Prime Minister for the education recovery program to promote education in emergency

CAMPE published an "Open Appeal" on the *Daily Samakkal* (10 June 2021), the *Daily Star* (14 June 2021) and *The Daily New age* (15 June 2021) to the Honorable Prime Minister focused on the education recovery program to promote education in emergency.

The major issues include allocation of 20% of the national budget for education, expand social safety net programs, health checks and mentoring of students, and counseling for students and parents. It also asked for increased investment in education to make online and ICT-based learning a regular feature in schools. The Appeal focuses on the ICT infrastructure, connectivity, broadband access, availability of smart devices such as tablets, educational technology support, and training for teachers. Consider school opening by maintaining safety standards and supporting teachers and parents to cope with the new normal.



A "Memorandum" to the Finance Minister to ensure the allocation of national budget allocation for education

CAMPE has prepared a 'Memorandum' requested to increase allocation of National Budget 2021-22 for education based on the suggestions / recommendations received from the national and sub-national level consultations and submitted it to the Hon'ble Finance Minister with copies to the Ministers of Planning, Education and Primary and Mass Education for continuing its lobby and engagement with the champions in government and CSOs.

TV Talk show on titled Bangladesh Labour Law 2006 and Rights of Domestic Workers as Labour: Our Role

As part of the observance of International Domestic Workers Day (IDWD) 2021, CAMPE and Bangladesh Institute of Labour Studies (BILS) jointly organized a Talk show titled Bangladesh Labour Law 2006 and Rights of Domestic Workers as Labour: Our Role on 18 June 2021 in Ekattor Sangoj on Ekattor TV. The objectives of the Talk show were to draw the attention of the policymakers for inclusion of domestic workers in the Bangladesh Labour Law, to formulate a legal framework to implement the Domestic Workers Protection and Welfare Policy, 2015 and to ratify the ILO Convention 189.



Research, Documentation & Publications


Education Watch Study 2020

Education Watch Reports are research-based independent studies on particular aspects of basic education in Bangladesh, which have been produced almost every year since 1999. During the COVID 19 pandemic situation, CAMPE also conducted the Education Watch Study. The study revealed that the COVID-19 pandemic has laid bare the pre-existing weaknesses of basic education (pre-primary to tertiary) in respect of access and equity, quality, relevance, governance, and management aspects. However, the urgent concern now is when and how children's learning may re-start. And in re-starting, how the losses in learning may be recovered without aggravating further pre-existing disparities.



In this regard, a virtual Multi Stakeholder Sharing Session on the Preliminary Findings of the study `Education and COVID 19 Response: Bringing Schools and Learning Back on Track` was held on 17 January 2021.

Hon'ble State Minister for Ministry of Primary and Mass Education graced the occasion as the Chief Guest, whereas Aroma Dutta MP, Md. Mahub Hossain, Secretary, Ministry of Education (MoE) and Golam Md. Hashibul Alam, Secretary, Ministry of Primary and Mass Education (MoPME) graced the program as Guests of Honor. Dr. Q. K. Ahmad, Chairman of Palli Karma-Sahayak Foundation (PKSF) & Chairperson of Education Watch Chaired the session.



There have ten-point recommendations based on the study findings, i.e safety measures for school re-opening, ensure personal health safety at schools, recovering education loss, community involvement, etc.

Community scoring, planning and monitoring on formal services

To monitor services, empower citizens, and improve the accountability of service providers CAMPE and its partner organizations (PASS & SERAA) organized a total number of 51 input tracking meetings, interface meetings, and joint action planning and display setting meeting by this process. The CWG members, community people implemented joint monitoring on their pre-set action plan 15 times.



Policy Brief on Education Response to COVID-19 Pandemic

CAMPE has prepared a Policy Brief on education response to the COVID-19 pandemic. The brief said governments should protect education financing in national budgets, Official Development Assistance, and greater cooperation on debt.

- To cope better with future crises, governments should strengthen the resilience of education systems by placing a strong focus on equity and inclusion and on reinforcing capacities for risk management;
- Despite the delivery of lessons by radio, television, and online, and the best efforts of teachers and parents, many students remain out of reach;
- Learners with disabilities, those in minority or disadvantaged communities, displaced and refugee students and remote areas are at the highest risk of being left behind. And even for those who can access distance learning, success depends on their living conditions, including the fair distribution of domestic duties;
- The unexpected shock of the COVID-19 pandemic with its health, social, and economic impact has brought to the fore the critical need for emergency preparedness and response capacity. The educational implications are immediate, and there is a longer-term need to build resilience to various types of vulnerabilities;
- Efforts to respond to COVID-19 should also include coordinated planning for back-to-school campaigns and strategies, including accelerated learning programs explicitly targeting the vulnerable groups, to address existing and increasing inequalities by preventing dropouts. It is also essential to understand the capacities of teachers, school leaders, and other education personnel as they support students in navigating the world of distance and remote learning, often without sufficient training, support, and resources.

Document the historical progress and contribution of the Teachers Association

CAMPE has taken the initiative to document the historical progress and contribution of the Teachers Association and stocktaking of some key initiatives that enhance the Teachers Association's Profile. These stories inspired young teachers to know how the teacher associations have grown in Bangladesh and how different visionary leaders have contributed to progressive journeys. CAMPE has selected 35 districts in the first lap to collect data from 64 Districts in two rounds. In this regard, CAMPE identified 35 local member organizations in the first round, of which 34 have collected data. The key findings from the survey data include:

- There are several teachers' associations, both registered and unregistered, working at the national and sub-national level in Bangladesh;

- Teacher Associations played a critical role in advancing the teachers rights and wellbeing, and many of them have a glorious record in influencing the national education policy and directives to uphold the dignity of teachers and ensuring their rights;
- The national-level association leaders have more opportunities to contribute to policy changes. In contrast, the sub-national level associations play a critical role in forming the opinion, organizing at the local level, supporting the national level teacher associations' initiatives, implementing policies and grievance redressed, negotiating conflicts, etc.
- There are plenty of information gaps which need to be fill-in through follow-up interventions and Key Informant Interviews.

Study on Explore challenges associated with the Metadata for Global Citizenship Education and ways to address those challenges

Campaign for Popular Education (CAMPE) intended to play a catalytic role in advancing education in terms of access with equity, quality, and relevance and improving the management and governance of education. CAMPE finds the proposed research initiative by the Bangladesh Bureau of Educational Information and Statistics (BANBEIS) is an important initiative to facilitate the informed decision-making process by improving knowledge management, promoting data-driven policy decision for equitable access, quality basic education. It also promotes the global citizenship and education for sustainable development, leaving no one behind, and preparing the graduates to improve their learning achievements, reduce dropouts, promoting life skills among adolescents, and better readiness for school to work transition.

This study has emphasized exploring the data management for SDG4.7, considering five priority areas and the data management flow Chart. It provides a visual presentation on the data source (i.e., providers), institutions, and inter-institution linkage and coordination. The plan has considered six priority areas for each of the thematic areas are (1) advancing policy; (2) transforming learning environments; (3) building capacity of educators; (4) empowering and mobilizing youths; (5) accelerating local level actions and enhancing partnerships; and (6) Improving data management and data literacy.

Capacity Building

Citizen Support Group orientations:

CAMPE and its partner organizations organized twenty-nine (29) Citizen Support Group orientations through meeting mode on primary education and health service governance. A total of 581 (male - 406 and female - 175) attended the orientations to informed the role of Community Watch Group (CWG) members to ensure good governance among service providers.

Participation of CAT Workshop:

A two (2) days long CAT workshop was organized by CAMPE on 7th and 9th March 2021 at CAMPE, where twelve (12) different levels of staff from CAMPE participated in the workshop. The workshop was facilitated by an external consultant. At the end of the workshop, the participants also prepared a draft plan of action



to address the issue within the organization as well as partner organizations.

Provide technical/financial assistance to support service providers on service delivery


CAMPE organized a day-long workshop titled 'Ensuring Services to the Domestic Workers: Our Role' held on 28 February 2021 at YWCA Auditorium. The main objective of the workshop is to inform, motivate & sensitize the officials of the government and non-government service provider's agencies to provide necessary services to the domestic workers. A total of twenty-one (21) participants including sixteen (16) females from different government agencies, people representatives, representatives from partner NGOs, etc. attended the workshop.



During the workshop, a brief presentation on the SUNITY Project and the Domestic Workers Protection & Welfare Policy 2021 were presented and discussed with the participants. Later on, the participants of concerned government agencies presented their own programs and activities. Moreover, concepts of gender, major issues, gender equity and justice, gender-sensitive behavior and role & responsibilities of the officials of service provider agencies were also discussed with the participants of the workshop.

Teachers Orientation for urban schools

During the reporting period, two Teachers' orientations have organized by CAMPE, where thirty principals/head teachers/teachers) of urban schools attended. Tapon Kumar Das, Deputy Director-CAMPE, Shahin Islam, Project Director- EGE project, Save the Children International (SCI), Aziza Md. Aziz, Manager-ICT & Communication, Save the Children International (SCI), participated in the discussion session. The EGE project and its linkages with the government initiatives were shared followed by a question-answer session. Mr. Shahin Islam, Project Director- EGE project, Save the Children International (SCI), responded to the questions raised by the participants.



Capacity building initiatives in cooperation with ASPBAE

CAMPE has accomplished some capacity building initiatives in cooperation with ASPBAE were as follows:

Strengthening understanding Prioritised SDG4 Indicators, Metadata and Methodology for SDG 4 Localisation included basic education indications and thematic issues like human rights, gender equality, cultural diversity, ESD and GCED (global citizenship), climate change, education in emergency. The initiatives focused on the Sendai framework, Charlevoix declaration, the charter for change, CRPD, etc., to understand international commitments on

reducing climate change and disaster risk projects, girls' rights, and rights of the indigenous people and persons with disabilities, etc. and how to incorporate in SDG 4.7.

Education financing and facilitate expenditure tracking

Enhance understanding of budget analysis and tracking in terms of size, share of education budget compared to the national budget. Besides also look into the sensitivity of the allocation so that the most marginalized are getting benefit of the education budget and also scrutiny about how the budget was utilized.

ICT for education

ICT for education helped education activists, including the member organization of CAMPE and Teacher associations' leaders on the innovative teaching-learning process for better engagement in advocacy for promoting blended learning approaches in education.

ICT for documentation of good practices and mobilize public opinion

ICT for documentation of good practices and mobilize public opinion and integrate ICT in daily life, including social mobilization, education, and workplace, with a particular focus on disaster risk reduction and climate change vulnerabilities, and other exclusion issues.

Networking

Participated in the regional and global platform

CAMPE actively engaged with the regional and global process, these are (1) APRCEM- People's Forum; (2) CONFINTEA VII South Asia sub-regional consultation and ASPBAE preparatory meeting to CONFINTEA consultation; (3) Regional Consultations on the GCM and ASPBAE's preparatory meeting to the consultations on GCM; (4) CCNGO meetings; (5) Webinar on INEE Publication Launch; (6) 3rd Meeting of Disability Inclusive Education in Asia Pacific Working Group (7) CSO2; (8) GPE board meeting positions; (9) Youth Leadership Workshop on Global Citizenship Education (GCED); (10) Sub-Regional (South Asia) Consultation Meeting on the Global Cooperation Mechanism; (11) Education in Emergencies Community of Practice; (12) Regional Consultation on the reform of the Global Education Cooperation Mechanism; and (13) GCE Gender Strategy, etc. CAMPE has shared its experience in International Financing Group (IFG) meetings and the privatization in Education and Human Rights Consortium (PEHRC).

CAMPE has shared its innovative approaches of advocacy and showcases how the equity and marginalization issues have been addressed and the need for increased financing for education to IFG. It would contribute to strengthening the replenishment campaign of GPE. CAMPE has engaged in the CSO2 mechanism and raise the issue of tax justice and domestic resource mobilization. It has also participated in the GPE Board meeting and supported the CSO2 representatives as technical advisers. In addition, CAMPE personnel have participated in Project Design and Management training organized by the EoL regional office.

National Level Participation

- CAMPE participated in different government committees and task force meetings/training/capacity-building workshops to establish learning collaborative for strengthening civil society organizations. It has contributed to regular virtual meetings and involved in the Education Sector Plan, LEG & Education Cluster, National Actions for Drowning Prevention, and other State-led and CSO initiated processes;

- As an active member, CAMPE participated in various programs organized by the “Shamajik Protirodh Committee” for advancing gender equality and gender justice at all levels through gender mainstreaming. “Shamajik Protirodh Committee” is a platform of sixty-four (64) NGOs coordinated by Bangladesh Mohila Parishad (BMP) working to stop violence against women and promoting women’s rights;
- Citizens’ Initiatives on CEDAW, Bangladesh (CIC-BD) are an active civil society platform of 57 non-government women and human rights organizations. As a core member of the platform, CAMPE participated in planning meetings for proper implementation of CEDAW in Bangladesh;
- CAMPE participated and contributed to popularize the concept of Global Citizenship Education Development (GCED) initiated by UNESCO Dhaka;
- CAMPE attended meetings of the Civil Society Alliance (CSO Alliance);
- CAMPE participated in regular meetings of the “Back to School Campaign” alliance facilitated by SAVE.

Participation in Securing Rights project related meetings

Weekly Project Coordination Meeting:

To keep on track of project activities during the COVID 19 pandemic situation through coordination and sharing of learning among the partner organizations for further improvement, OXFAM in Bangladesh introduced weekly coordination meeting with the participation Program Manager/Coordinator, Meal Officer and Accounts Officer of respective organizations. During the reporting period, CAMPE Team participated in all meetings and documented and disseminated three (3) minutes of the meeting.

Project Management Committee Meeting:

A day-long Project Management Committee (PMC) meeting was organized by Oxfam in Bangladesh on 15 February 2021 at Hotel Platinum, where 4 members team headed by Manager (Finance & Admin), from CAMPE participated. CAMPE presented the progress of the project activities and shared a draft plan of Action for 3rd Year of the project in the meeting.


Participation of Meal Workshop:

To share the alternative educational support program under the EGE project during COVID-19 pandemic situation, survey findings and challenges; the way forward and bring back children safely to school after COVID-19, Campaign for Popular Education (CAMPE) and Save the Children jointly organized a webinar titled 'Alternative Educational Support during Covid-19'.



The webinar was chaired and moderated by Dr. Manzoor Ahmed, Professor Emeritus, and Vice-Chair, CAMPE Council while the guest of honor includes Mr. Tapan Kumar Ghosh, Director General (Additional Secretary), Bureau of Non-Formal Education (BNFE); Rasheda K. Choudhury, Executive Director of CAMPE, Mr. Shahed Alam, Chief Corporate and Regulatory Officer of Robi Axiata Ltd.; Mr. Mohammad Mohsin, Manager, Early Learning of UNICEF-Bangladesh; Mr. Narayan P. 
CAMPE Council Meetings


The major decisions of the AGM were as follows:

INDEPENDENT AUDITOR'S REPORT

To the members of General Body of GONO SHAKKHORATA OBHIJAN (Campaign for Popular Education (CAMPE))

Report on the Audit of the Financial Statements

Opinion

We have audited the financial statements of GONO SHAKKHORATA OBHIJAN (Campaign for Popular Education (CAMPE)) (the entity), which comprise the statement of financial position as at 30 June 2021, and the statement of profit or loss and other comprehensive income, statement of receipts and payments and statement of changes in net assets for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying financial statements give a true and fair view of the financial position of the entity as at 30 June 2021, and its financial performance and its cash flows for the year then ended in accordance with International Financial Reporting Standards (IFRSs) and other applicable laws and regulations.

Basis for Opinion

We conducted our audit in accordance with International Standards on Auditing (ISAs). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the entity in accordance with the ethical requirement that are relevant to our audit of the financial statements in Bangladesh, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management is responsible for the preparation of financial statements that give a true and fair view in accordance with IFRSs, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the entity's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the entity or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the entity's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with ISAs will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.


